Adopting Requirements:

1. It is understood that the undersigned cannot, and will not, trade or re-adopt this bird after it has been adopted from Beaks and Bills.
2. If you no longer want this bird or can no longer take care of it, FOR ANY REASON, you agree to return the bird to Beaks and Bills with no questions asked.
3. Beaks and Bills must approve your cage before the adoption process can be complete.
4. You agree to provide an atmosphere free of screaming or loud noises, smoking or harmful chemicals and food inappropriate for birds. You agree to keep this bird safe from other animals and children.
5. You agree to allow Beaks and Bills, from time to time, to visit and inspect the birds living conditions and its behavior in its new environment.
6. If, for any reason, Beaks and Bills Rescue feels, at their sole discretion, that the bird's needs are not being met, we will request the return of the bird(s) to the rescue. The undersigned agrees that in such a situation, the bird(s) shall be returned to the rescue and all rights, claims and ownership to bird(s) will be relinquished.
7. You agree to provide a new address and phone number if you move.
8. If these requirements are not met or upheld, Beaks and Bills will be entitled to a \$5,000.00 fee and will seek legal prosecution for the return of the bird(s).

By signing below, the parties agree to be bound by this agreement. Adopting party confirms that the information contained in this agreement is true to the best of his/her knowledge or belief. The adopting party understands all requirements and agrees to hold Beaks and Bills Bird Rescue harmless in any capacity. The adopting parties agrees that if any action or enforcement has to be taken to uphold this agreement by Beaks and Bills, all expenses for all parties will be assessed to the undersigned. This agreement becomes in effective when this document is signed and dated.
